This brochure lists over 800 courses available for cross-registration in many departments from Accounting to Women's Studies. Enroll in a course at another campus and receive full credit. In general, full-time undergraduates pay no extra charges.

PLEASE NOTE:

Saint Joseph College students are limited in the number of lower division courses that they may take. Check with the SJC Registrar.

Trinity College students who have earned 18 credits are not eligible to take community college courses. Trinity students also are not allowed to cross-register for a course that is presently offered at Trinity. Trinity's I.D.P. students may cross-register.

It is not recommended that seniors anticipating Spring graduation cross-register due to lag time transferring credits between institutions. Please check with your registrar.

GUIDELINES

Qualified full-time undergraduate students from the following Consortium institutions are eligible for cross-registration:

Saint Joseph College
Trinity College
University of Hartford

No tuition or registration fee is paid by the student to the host school. Transportation, books and special lab/film/music fees are the student's responsibility.

The academic calendars vary at the different Consortium schools, and it is the responsibility of the student to become familiar with the host school calendar, vacation periods, and the last day to withdraw from a course without penalty.

CROSS-REGISTRATION FOR SPRING 2010: HOW TO DO IT

At this time we are presenting two possible ways for you to cross-register. Cross-registration for both methods begins on **December 1, 2009**. Please see **Process A (the electronic method)** and **Process B (the paper method)**. Instructions for both of these processes are printed below. *Process A* instructions allow you to download the cross-registration form, complete it in full, save it in your documents, and email it to the host school (school offering the course you want to take). *Process B* instructions require your going in person to the Registrar's Office of the host school with your completed cross-registration form. Process B *may* be used in all cases of cross-registration, and *must* be used in specific cases. Choose one of them according to the following information:

If your home school is Saint Joseph College, Trinity College or University of Hartford and you are cross-registering for a course at any one of those three schools, follow the instructions under either Process A or Process B.

If our home school is Saint Joseph College, Trinity College or University of Hartford and you are cross-registering for a course at Capital Community College, Central Connecticut State University, Goodwin College, Hartford Seminary or University of Connecticut, you *must* use Process B.

INSTRUCTIONS FOR PROCESS A – ELECTRONIC METHOD

- STEP ONE: Print these instructions.

- STEP TWO: Download the cross-registration form. Complete it in full. Save it to your documents.
Click here to download the form.
- STEP THREE: Obtain via email verification and approval from your advisor and registrar (instructions follow) that you are eligible for cross-registration and that your course request is approved. Please note that, if your home school is Saint Joseph College, only your advisor must verify that you are eligible for cross-registration and that your course is approved. If your home school is Trinity College or University of Hartford, you will need verification from your advisor *and* your registrar.

To the Home School Registrar: (Saint Joseph College is crossreg@sjc.edu; Trinity College is crossreg@trincoll.edu; University of Hartford is crossreg@hartford.edu).

Send an email to your registrar. Attach a copy of your completed cross-registration form from Step 2 to a note requesting that they verify to you via return email that 1) you are approved for cross-registration and 2) your request for the course is approved for **Spring 2010**.

When you receive that email, save it.

To the Home School Advisor:

Send an email to your home school advisor. Attach a copy of the completed cross-registration form from Step 2 to a note requesting that they verify to you via return email that 1) you are approved for cross-registration and 2) your request for the course is approved for **Spring 2010**.

When you receive the email, save it.

STEP FOUR (if needed): With a small percentage of courses, the approval of the course instructor is required. These courses have a “Y” after them in the Course List. You may want to call the instructor to see if you are approved, or you may prefer to email the instructor asking for his/her approval to take the course. In any case, ask the instructor to send you an email stating that you are approved to take the course.

When you receive that email, save it.

STEP FIVE: Send an email to the Registrar of the host campus. Saint Joseph College is crossreg@sjc.edu; Trinity College is crossreg@trincoll.edu; University of Hartford is crossreg@hartford.edu).

With your note expressing your desire to cross-register at that campus, include the following attachments in your email:

1. Your completed cross-registration form (Step 2)
2. Emails from the registrar and the advisor of your home campus (Step 3). These may be forwarded in separate emails. *Be sure to identify your name, home institution, host institution, and name of course for which you are cross-registering in each email.*
3. If required, the email from the course instructor stating his/her approval (Step 4)

You will receive an email from the registrar at the host campus regarding the status of your application in three business days. Hopefully space will be available, and you will be successfully cross-registered.

If you would like to cross-register for more than one course, please repeat this process for each course.

INSTRUCTIONS FOR PROCESS B – PAPER METHOD

1. Select one or more courses. Your registrar has catalogs from the other colleges, or you may call the Hartford Consortium (860-905-5016) to have a course description read over the phone.
2. Check with your home-institution registrar to make sure that the course will be accepted for credit. If so, ask the registrar for a cross-registration form.
3. Visit with your faculty advisor to discuss your decision. If in agreement, have your advisor sign the form.
4. If permission of the host school instructor is needed, you may obtain his/her phone number form the Consortium office and then arrange a visit.
5. Finally, take the completed and signed cross-registration form to the registrar's office of the school where you wish to enroll. You must wait until **December 1, 2009**, the date that cross-registration starts.
